Creating Jobs in Lycoming County: Shapiro Administration Investing \$4.6 Million to Help PMF Industries Expand into the Clean Hydrogen Market & Grow Pennsylvania's Clean Energy Industry

On December 20, Governor Josh Shapiro announced the Commonwealth is investing \$4.6 million into PMF Industries to help the 63-year-old Pennsylvania company enter the clean hydrogen market, growing Pennsylvania's clean energy industry. The Commonwealth funding will support a more than \$7 million expansion of the Lycoming County-based manufacturing company that will create at least 20 new, full-time jobs and retain 78 existing jobs. PMF Industries will construct a 16,000-square-foot addition to its existing manufacturing operations in Williamsport that will house a new hot spinning machine and aluminum heat treating and tempering furnace. The expansion will allow the company to enter the clean hydrogen market — producing metallic liners to store hydrogen and allow it to be transported by trucks, planes and boats.





- Fans for fan coils South Carolina manufacturer is seeking a domestic supplier of fans for fan coils, including the fan motor, fan rotor and fan casing. These items are intended to be used for residential and commercial appliances. This is an annual request of roughly 2500 units per year at \$90 a unit.
- Coils for fans South Carolina manufacturer is seeking a domestic supplier of coils for fans. These are water to air heat exchangers, made of copper tubes and aluminum fins. The heat exchangers consist of soldered copper pipes with hydraulic connections, onto which aluminum fins are pressed. These items are intended to be used in fan coils for residential and commercial appliances. This is an annual request of roughly 1500 units per year in 16 different sizes and versions.
