

U.S. Department of Commerce Requests Information on Supporting a Strong American Semiconductor Industry

The U.S. Department of Commerce requests input to inform the planning and design of potential programs to incentivize investment in semiconductor manufacturing facilities and associated ecosystems; provide for shared infrastructure to accelerate semiconductor research, development and prototyping; and support research related to advanced packaging and advanced metrology to ensure a robust domestic semiconductor industry. Manufacturing USA Fostering Projects to Power the Clean Economy

Reducing energy consumption and using energy as efficiently as possible are crucial for U.S. manufacturers to not only reduce emissions and confront the climate crisis but to also create jobs for current and next generation workers and increase America's global competitiveness in the industrial sector.



[Manufacturing USA](#) is a network of 16 institutes and their sponsoring federal agencies — the Departments of Commerce, Defense and Energy — that was created to secure U.S.

global leadership in advanced manufacturing through large-scale public-private collaboration on technology, supply chain and education and workforce development.

The network is responding to the need for increased energy efficiency and reductions in carbon emissions by fostering projects that will lead to major reductions in manufacturing energy use and costs, and provide the basis for innovative new green products.

Given that future energy consumption is likely to increase, cost-effective power conversion in industrial applications will prove vital to save energy and lower expenses for industry, reduce emissions, industrial waste, materials and water usage, and improve the life cycle energy efficiency of manufactured goods. Manufacturing Roundtable Informs Legislators of Program, Policy Priorities

On Tuesday, February 1st, Eric Esoda, NEPIRC's president & CEO, hosted a manufacturing roundtable for a joint meeting of the Pennsylvania House Democratic Policy Committee and the Pennsylvania House Manufacturing Caucus in State College. The roundtable was requested by [Rep. Ryan Bizzarro](#), chair of the House Democratic Policy Committee, and [Rep. Mike Schlossberg](#), chair of the House Manufacturing Caucus.



The roundtable consisted of 10 manufacturing executives from across Pennsylvania, including leaders within [Metal Integrity East & West](#), [Restek Corp.](#), [Diamondback Covers](#), [Lake Erie Rubber & Manufacturing](#), [GeorgeKo Industries](#), [ILSCO Extrusion](#), [The Fredericks Co.](#), [C.L. Sturkey, Inc.](#) and [Lehigh Valley Plastics](#).

Within the 90-minute roundtable, which consisted of live participation and virtual attendees, manufacturers expressed their greatest challenges, barriers, opportunities and advantages relative to workforce attraction and retention, the adoption of advanced manufacturing technologies and the mitigation of supply chain risks through re-shoring and creating PA-based supplier networks. The participating manufacturers also offered suggestions and ideas as to what programs, policies and statewide initiatives should be created or expanded in order to accelerate their recovery from the COVID-19 pandemic and maximize their long-term growth and competitiveness. 71 Jobs Coming to Monroe County With Relocation of Black

Buffalo 3D Manufacturing Operation to Pennsylvania

Recently, Governor Wolf announced that [Black Buffalo 3D Corporation](#), a manufacturer of large-scale 3D construction printers, is relocating its manufacturing operation from New Jersey to Pennsylvania and creating 71 new jobs in Monroe County.

Black Buffalo 3D purchased approximately 106 acres in Smithfield Township, Monroe County, and will construct a 150,000-square-foot facility to manufacture 3D construction printers and a 3D printing training facility. 

New Business Opportunities: Companies Looking for Suppliers

NEPIRC is relaying these potential new business opportunities to manufacturers across our region:

- **Fiberglass Composite** – Oklahoma-based manufacturer seeking provider of fiberglass shafts to form core of horse and cattle whips. Shaft would be in lengths from 15" to 88" with an upper OD of 0.308" and lower (tip) OD of 0.095". Should be packable in boxes of 300-400 units. Purchase of 250,000/yr. is expected.
- **Plastic Sound Tubes (Toy)** – Toy company seeking domestic production partner for seamless plastic tubes (similar to PVC pipe) tuned to notes on a musical scale. Buyer will provide specifications of the tubes, which range from 12" to 24", such that they will yield the desired tones. However, precision is important in the manufacturing process. Tubes will be sold in kits of 8 with various colors to align with the pantones used in music classes. Items must pass ASTM F963-17 and CPSIA toy and child product safety standards and have no sharp edges. Company is currently purchasing in excess of 10,000 8-tube sets/yr. and desires a cost in the neighborhood of \$5 per set. Shipping to Iowa.
- **Fabric Adhesive** – Company with facilities nationwide and overseas hopes to connect with a domestic manufacturer of double-sided adhesive transfer tape to adhere to fabrics, cotton and blends. Adhesive should be similar in stickiness to the common size sticker on apparel and should not leave residue once removed. About 1-inch wide and manufactured to various lengths or on a roll. Company is currently purchasing from overseas supplier. Buyer is eager to engage in price and delivery discussions and hopes to reshore this item within 30 days.
